## 2024 OUTDOOR WATERING May 1 thru Sep 15

- **♦** 104<sup>th</sup> Ave, 104<sup>th</sup> Way water on dates ending in EVEN numbers
- ♦ Counter Dr, 105<sup>th</sup> Ave, Brighton Rd water on dates ending in ODD numbers
- ♦ For 2024, base rate of \$60 includes up to 12k gallons per month. No change from 2023
- ❖ No turf watering between 10:00 am and 6:00 pm -- Hand watering is okay
- Drip irrigation and hand watering of gardens, trees, and flowers is permitted outside of posted hours above
- Anti-siphon devices <u>MUST</u> be re-installed on ALL outside hose bibs, and automatic sprinkler systems must have anti siphon valves in place to keep system water supply safe from backflow.
- All hoses must have a nozzle or sprinkler head in place whenever in use to keep District's system pressure up
- The above restrictions are MANDATORY. Repeat violators will be fined
  - \$50 for second violation
  - 5 \$100 for third/ subsequent violations

### WATER REMINDERS

- ♦ Seasonal reading of meters will begin on **April 20**<sup>th</sup> and each 20<sup>th</sup> thereafter. Keep meter pits and lids clear of vehicles, water, rocks, dirt, shrubs, overgrown branches and grasses, etc. so that the meters can be easily read.
- "WELL WATER" signage must be CLEARLY displayed and viewable from street if used for irrigation
- ♦ All meter pits have non-drivable covers. If a vehicle runs over the lid it will eventually break. Damage to the actual meter or lid will be repaired at the expense of the customer.

#### WATERING TIPS

- **♦** If you would like your billing statement to be emailed, please contact 303-916-3800
- ♦ A significant increase in your bill, likely points to a leak or other issue with your plumbing or irrigation system. Call a plumber
- Save water and \$\$ by avoiding excess water overspray on streets, gutters, sidewalks
- Use a broom or blower instead of a water hose to clean driveways and patios

#### IMPORTANT FLUORIDE NOTICE

Do not use fluoride toothpaste or have fluoride treatments for your children as our tests show a higher range of fluoride in the water. Consult your dentist if you have any questions.

If you see the red light flashing at either well site, please notify any Board member below ASAP!
